

## 2 Steps to Releasing Your Cosigner

## 1. Qualify for cosigner release

To have your cosigner released from your private student loan:
☐ Your loan must be a prior CitiAssist Loan that was purchased by Discover.
☐ You must be at least 18 years of age.
☐ You must be a US citizen or permanent resident.
$\square$ You must have made the required number of consecutive monthly payments on time. Use the chart
below to determine the number of required payments.
☐ Your gross monthly income must be at least \$1,500.
☐ You must have a satisfactory credit history and pass applicable credit criteria including but not limited to, having no excessive delinquencies and a qualifying credit score. Please note, delinquencies with other creditors are taken into consideration.
☐ Your loan(s) must be in a repayment status.
