How To Get There: The Oregon Redwoods Trails are 11 miles southeast of Brookings. From Brookings, take US Hwy 101 south to County Road 896 (Winchuck Road). Turn right across Winchuck River to FS Road 1101. The trailhead is located at the end of road 1101.

Facilities: 1106 is a Wheelchair accessible (graveled) trail. Both Trails have Parking, trash deposit, barrier free restroom, picnic area.

Season Of Use: All year.

Attractions: 1106 This day-use trail in the Winchuck River Drainage, provides a unique hiking/ wheelchair opportunity through a grove of majestic old-growth coast redwood trees. 1107 This Hiking Trail, which starts on the Barrier Free Trail, loops down to the west into the upper Moser Creek drainage to access a grove of old-growth coast redwood trees. Redwood trees found on the Gold Beach Ranger District represent the only coastal redwoods (Sequoia sempervirens) found in the Pacific NW Region, located at the limit of their northern range.

Length And Difficulty: 1106 is 0.5 miles, one-way. Easy for hiking, more difficult for wheelchair use. 1107 1.2 miles one-way. Difficult with steep grades.

Limits: Hiking and wheelchair use only.

Restrictions: No horses, bicycles or motorized vehicles are allowed.

Leave No Trace: Help preserve the beauty of this area by using techniques to

reduce impacts and eliminate any evidence of your visit.

Pack It In, Pack It Out And Stay On The Trail: Collect all food and drink containers, plastic and paper garbage. Dispose of trash at the trailhead receptacle.

Drinking Water: Carry in your water.

- •Tallest trees up to 350 plus feet.
- •Small cones with tomato sized seed.
- •Reproduce by seed or sprouting.
