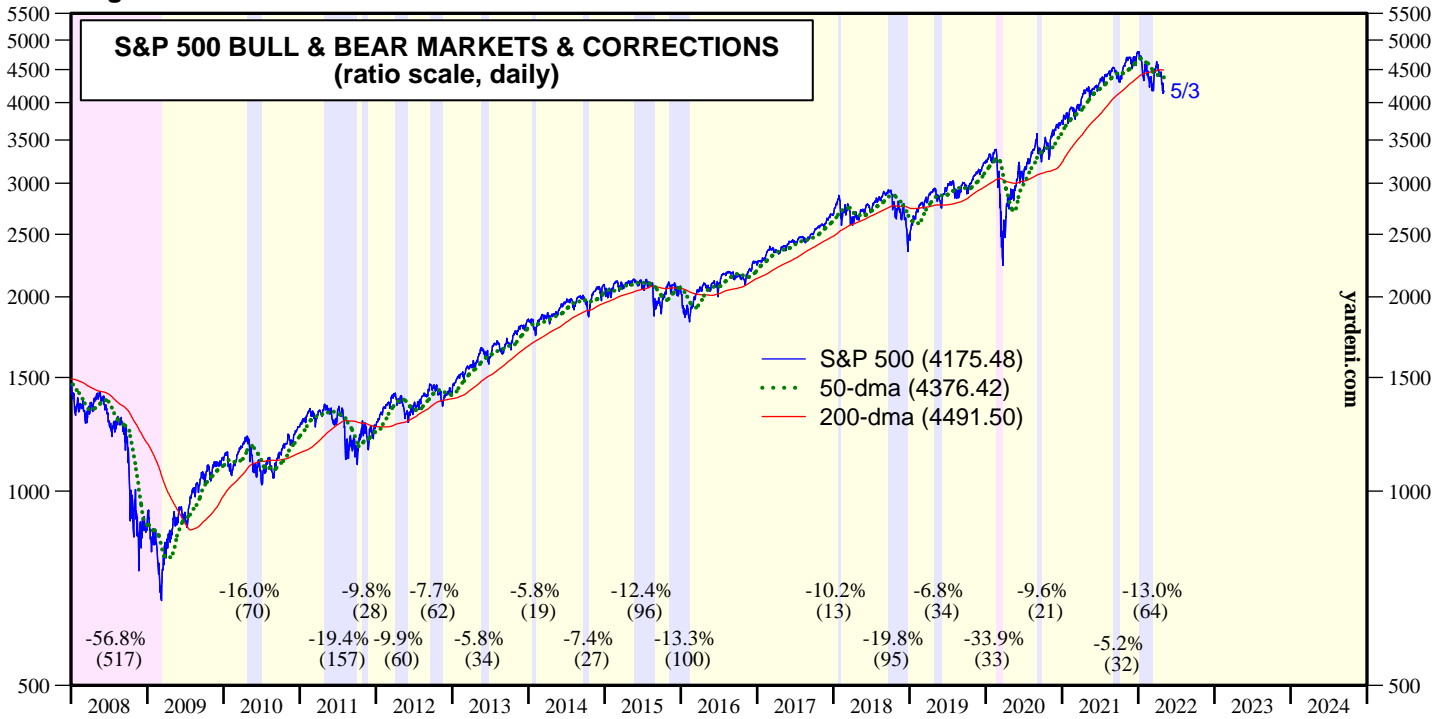

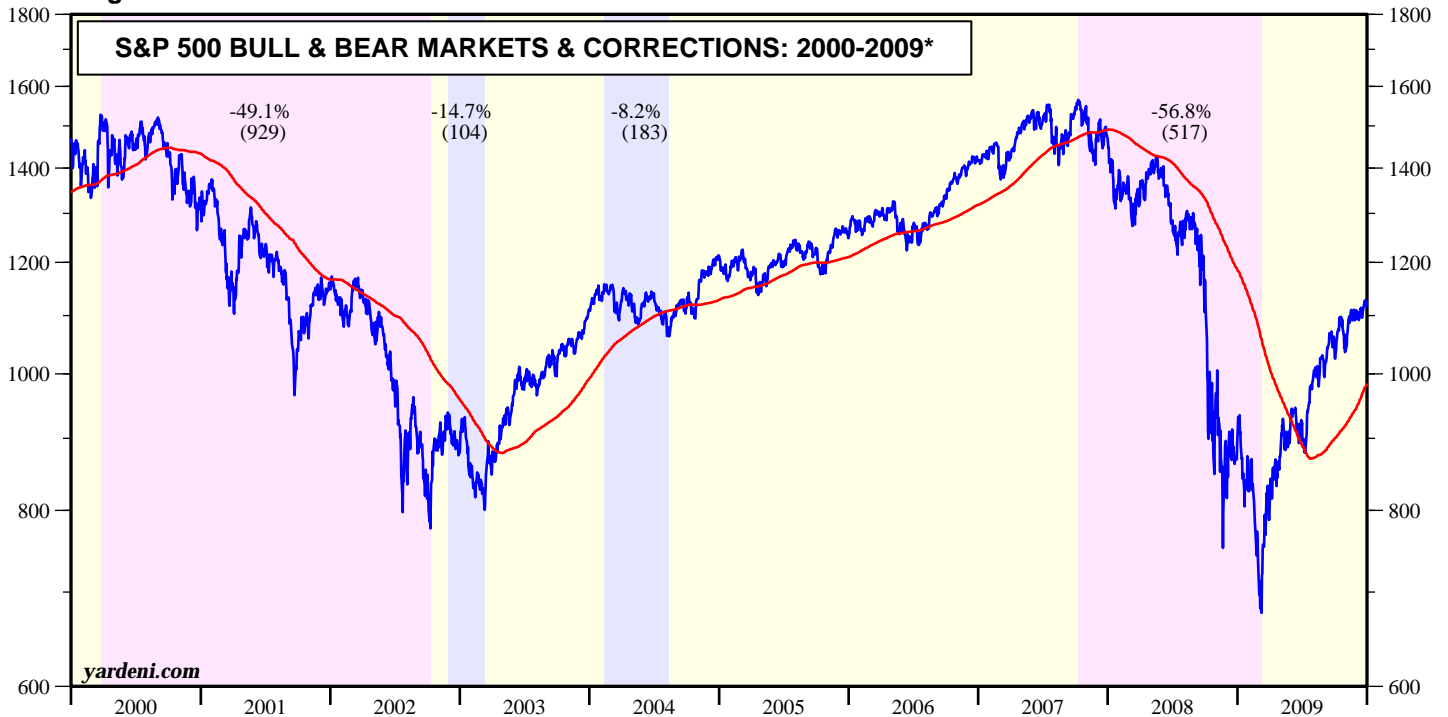

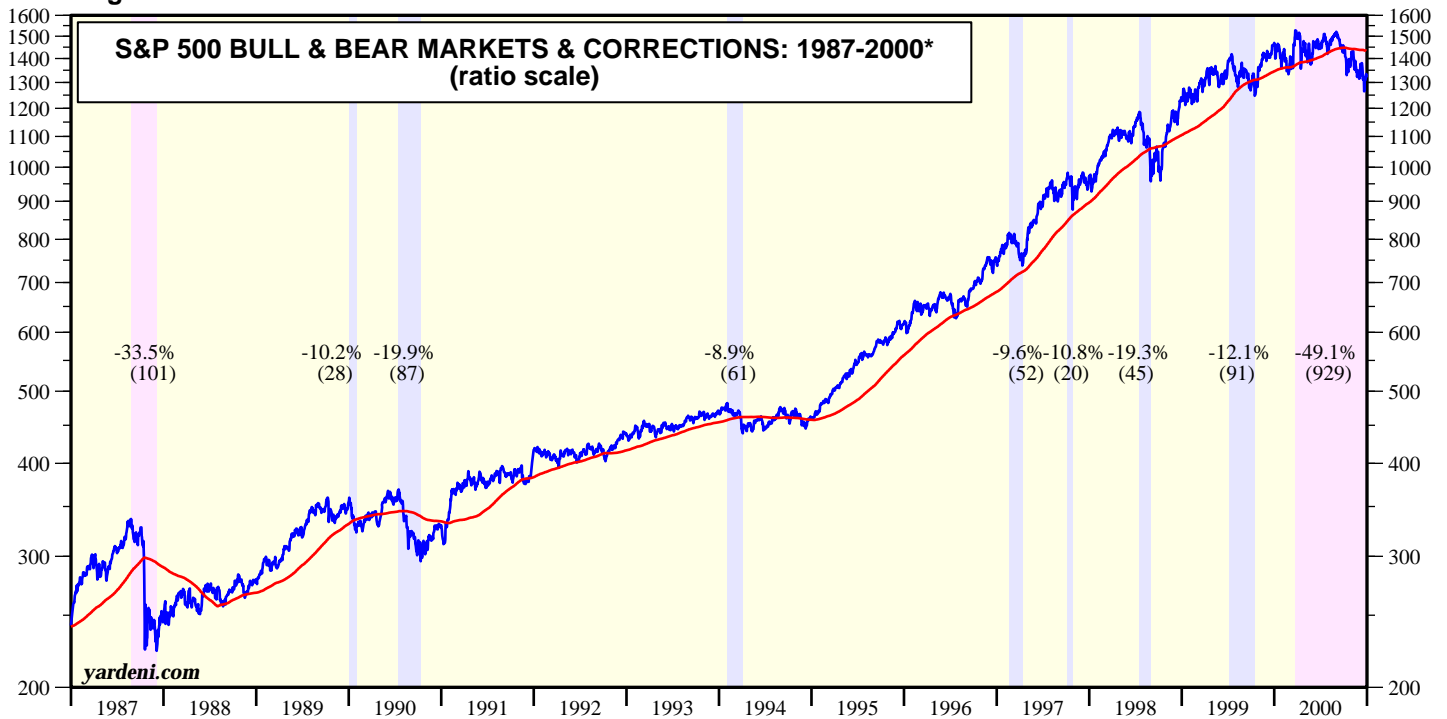

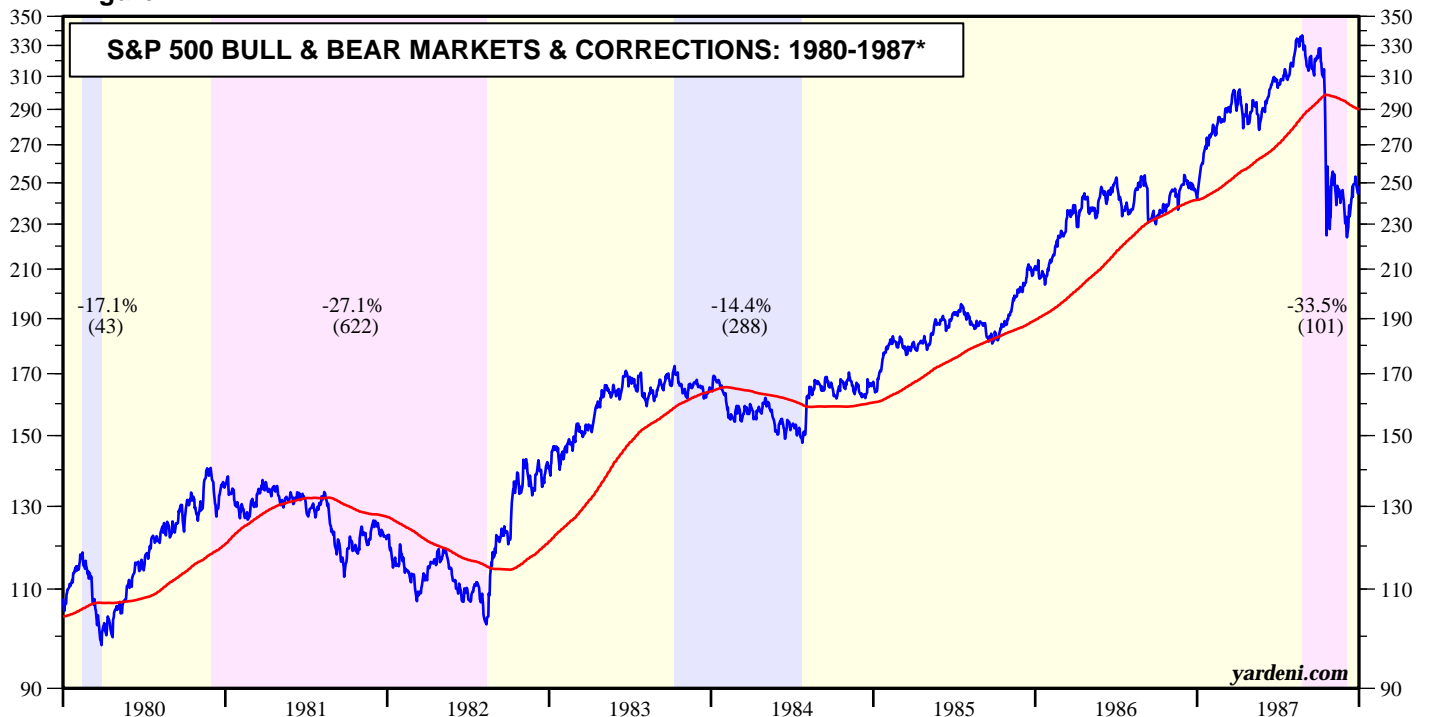

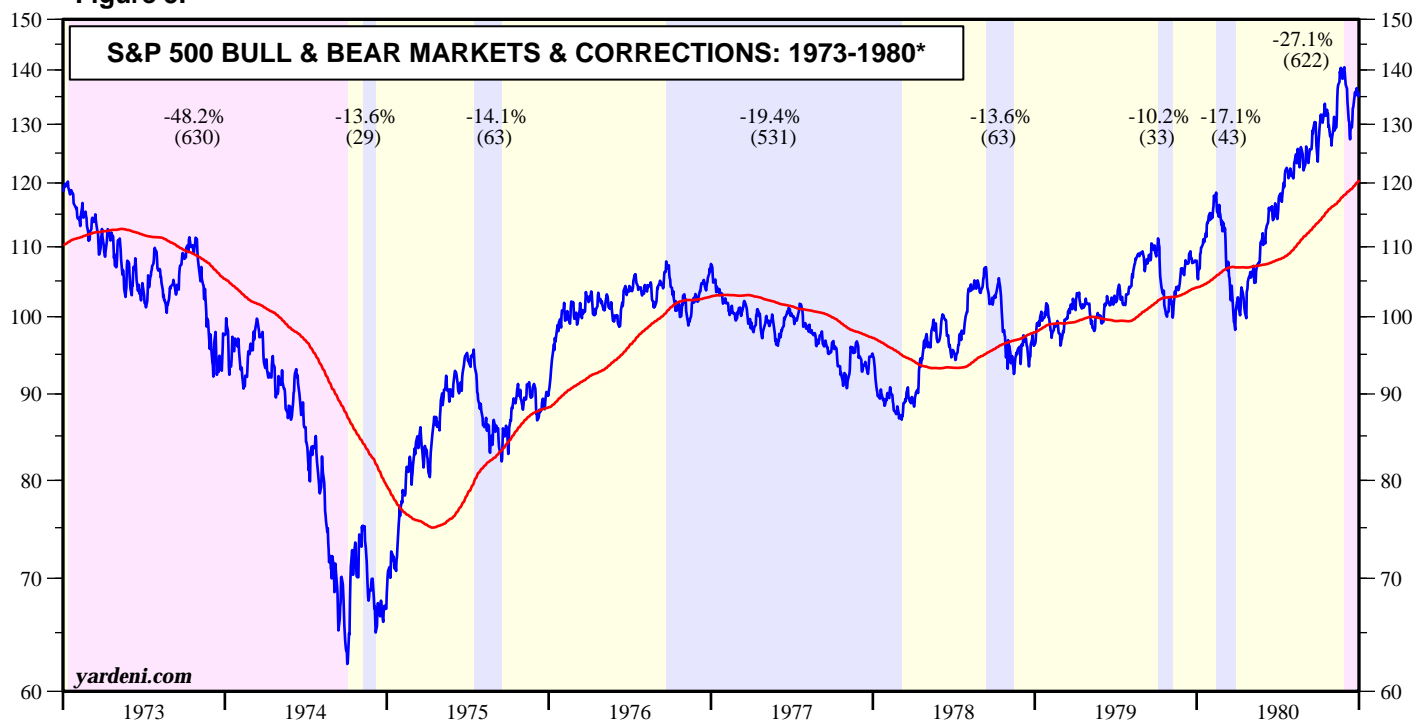

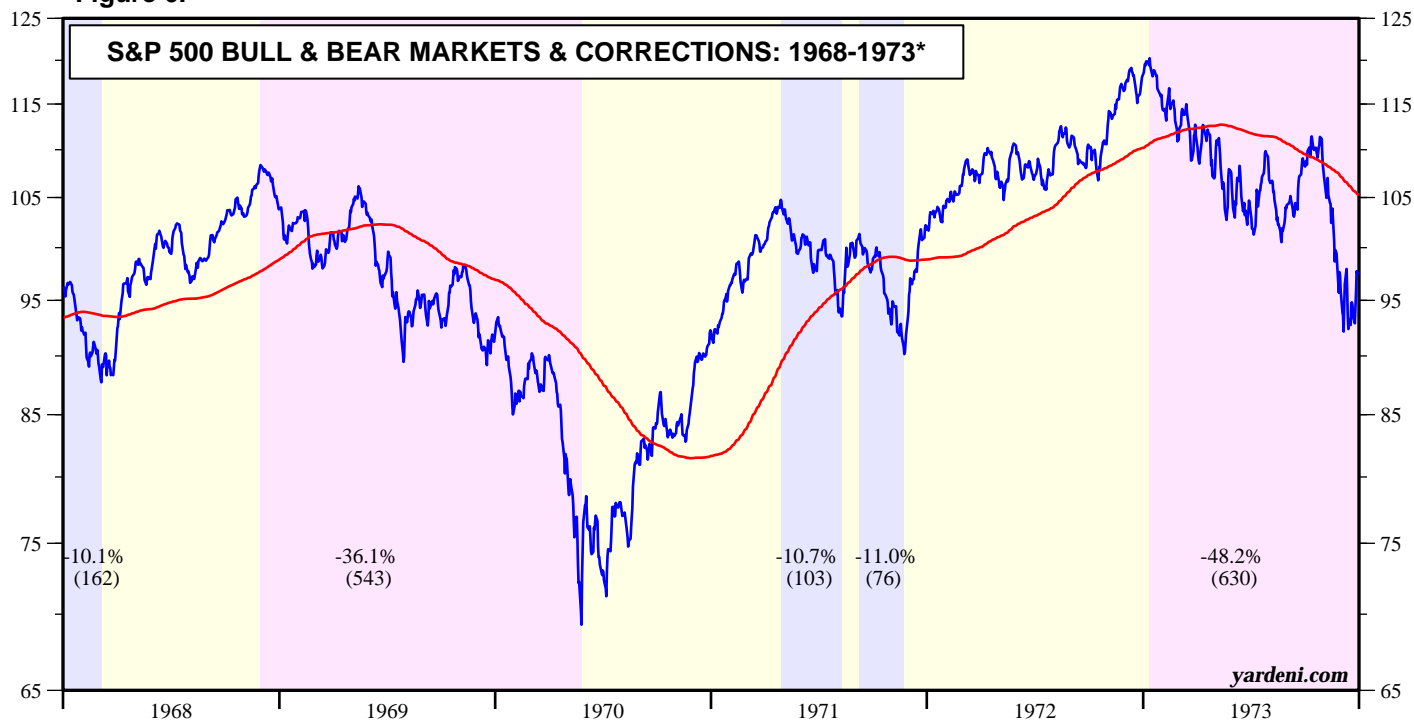


— 200-day moving average.

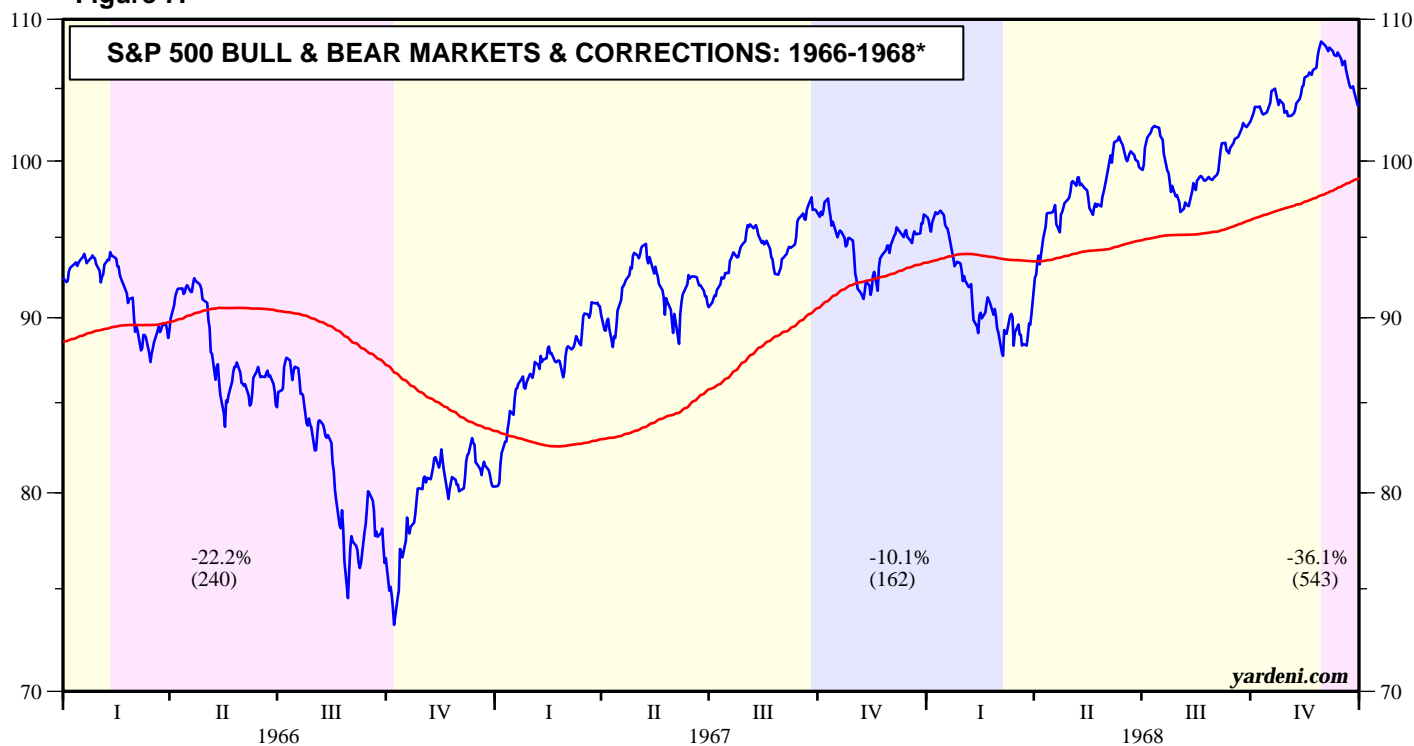

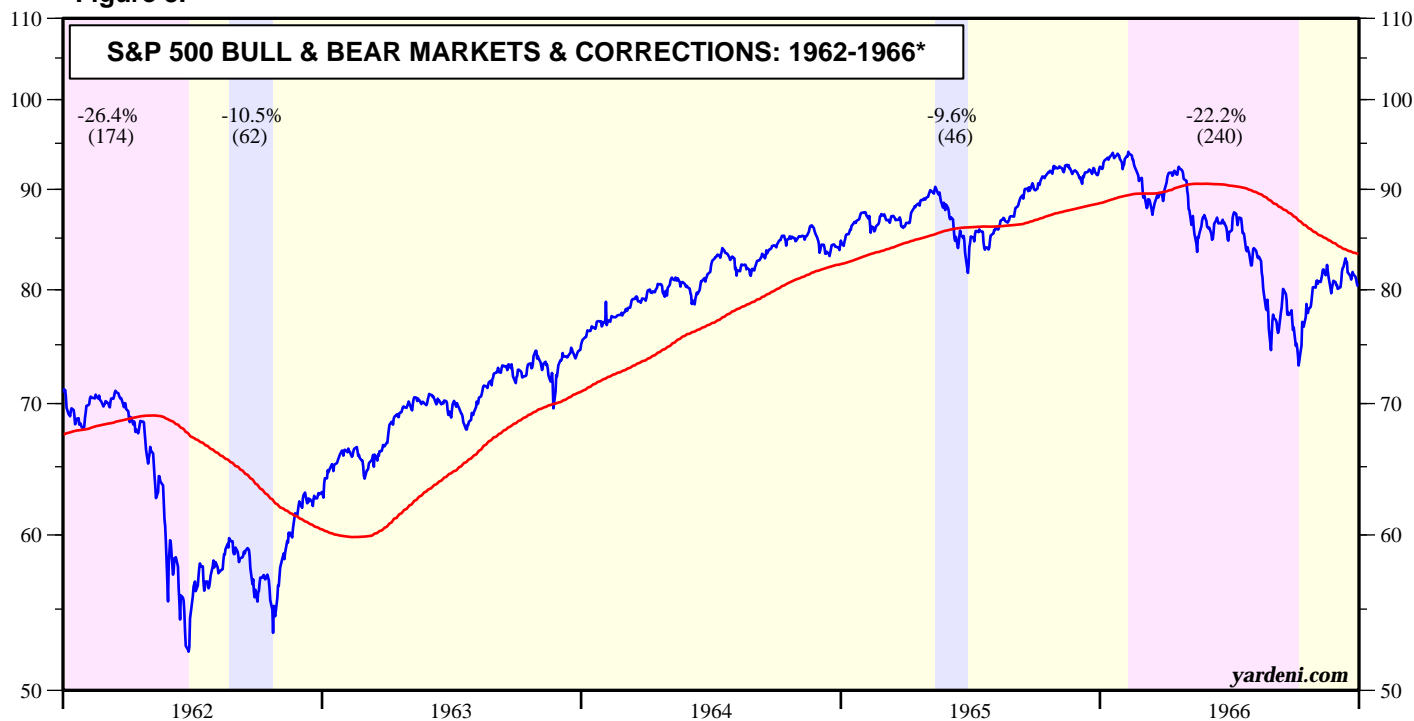


— 200-day moving average.

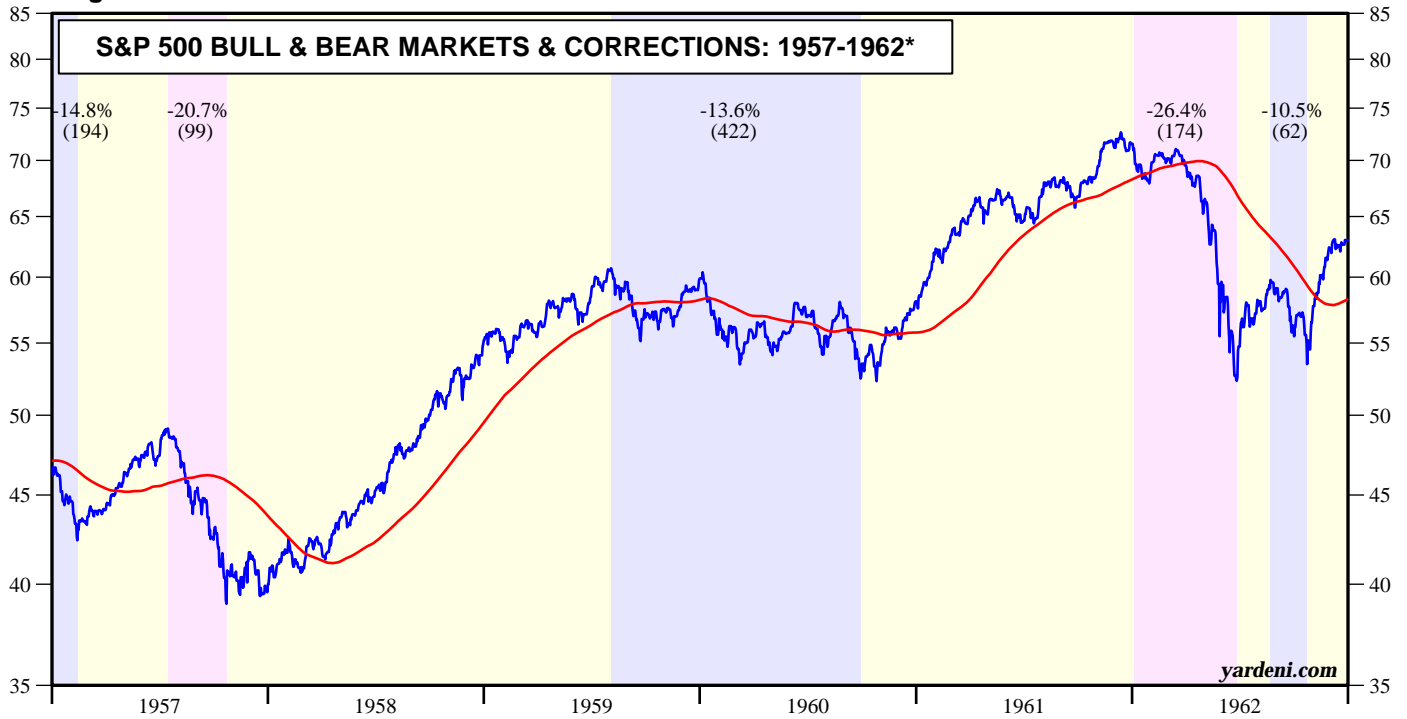

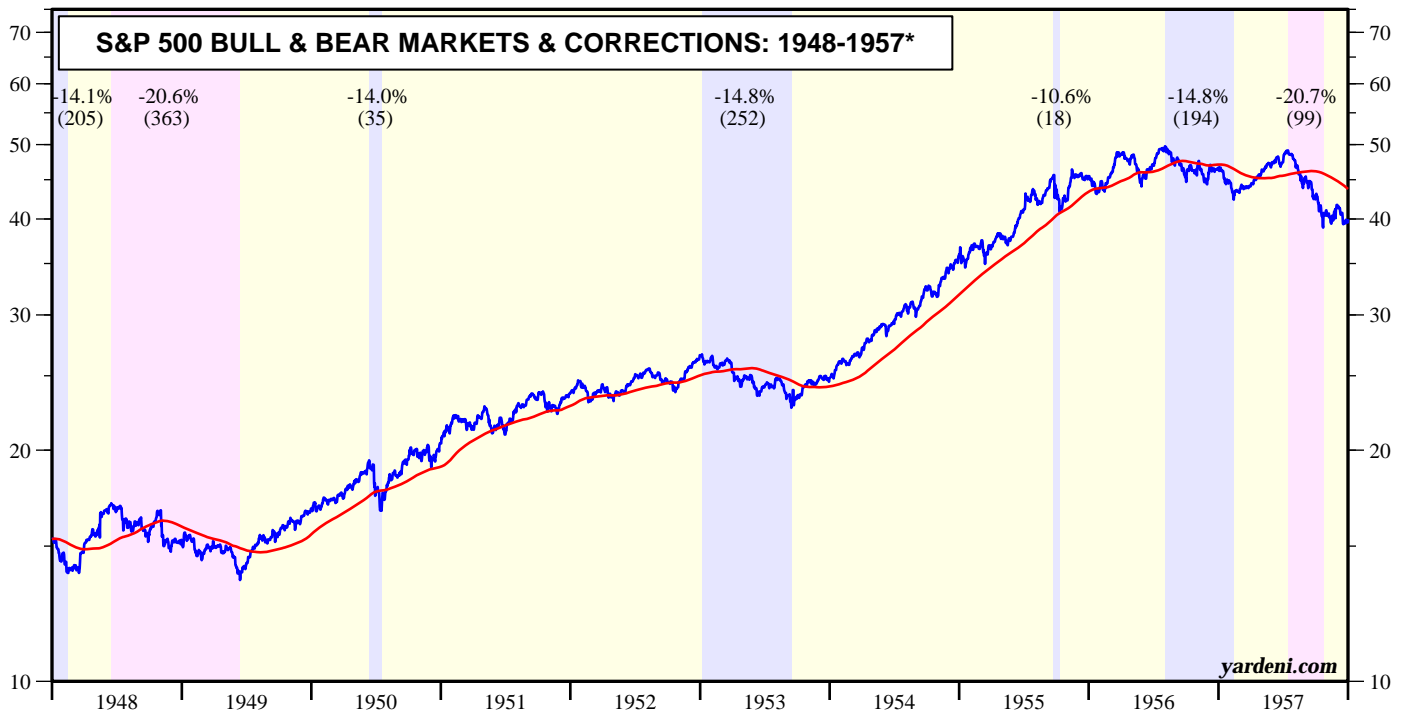


— 200-day moving average.

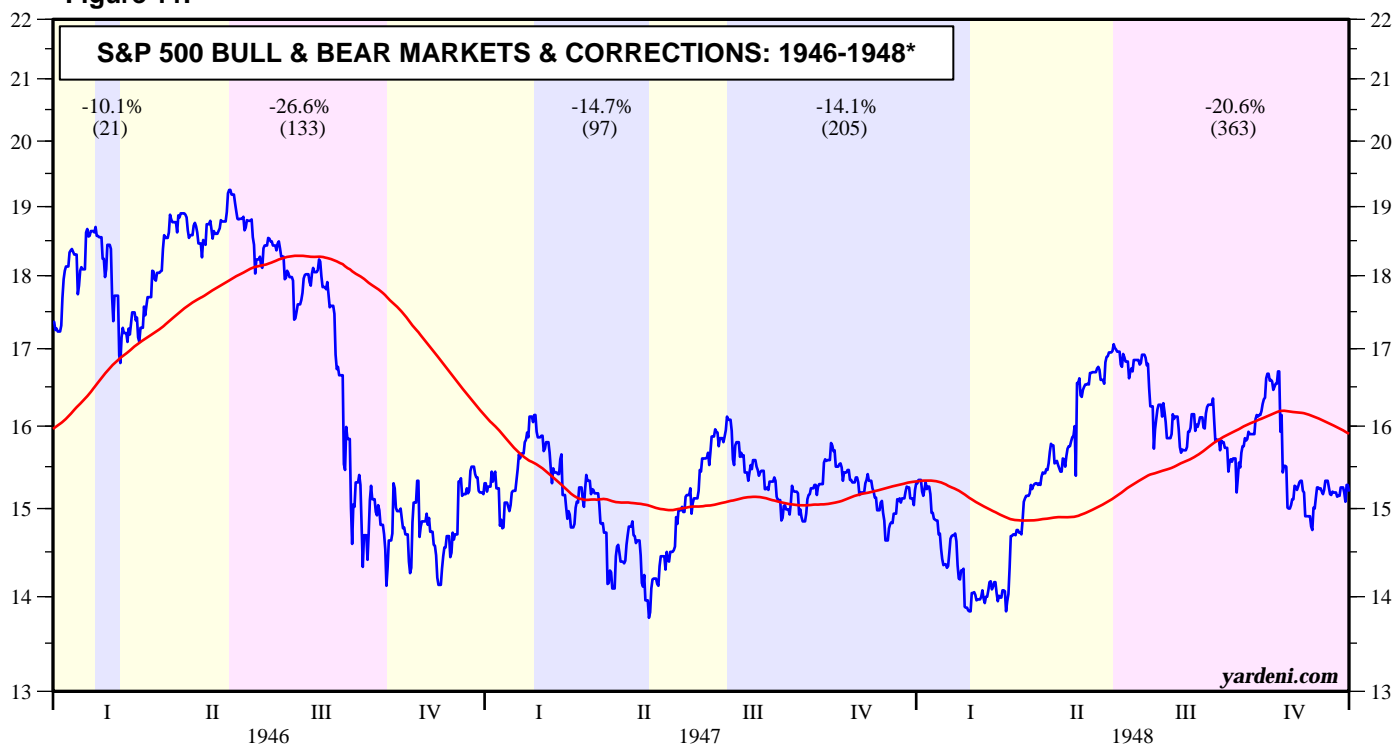

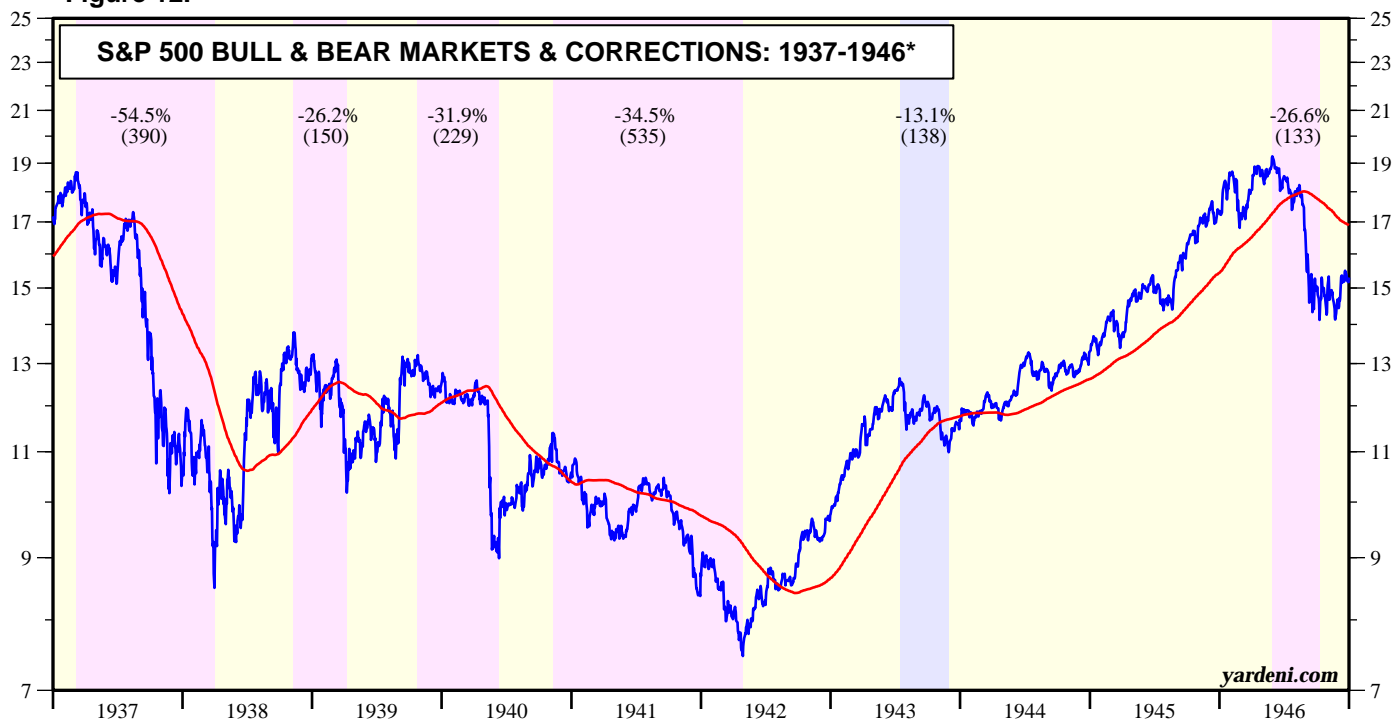


— 200-day moving average.

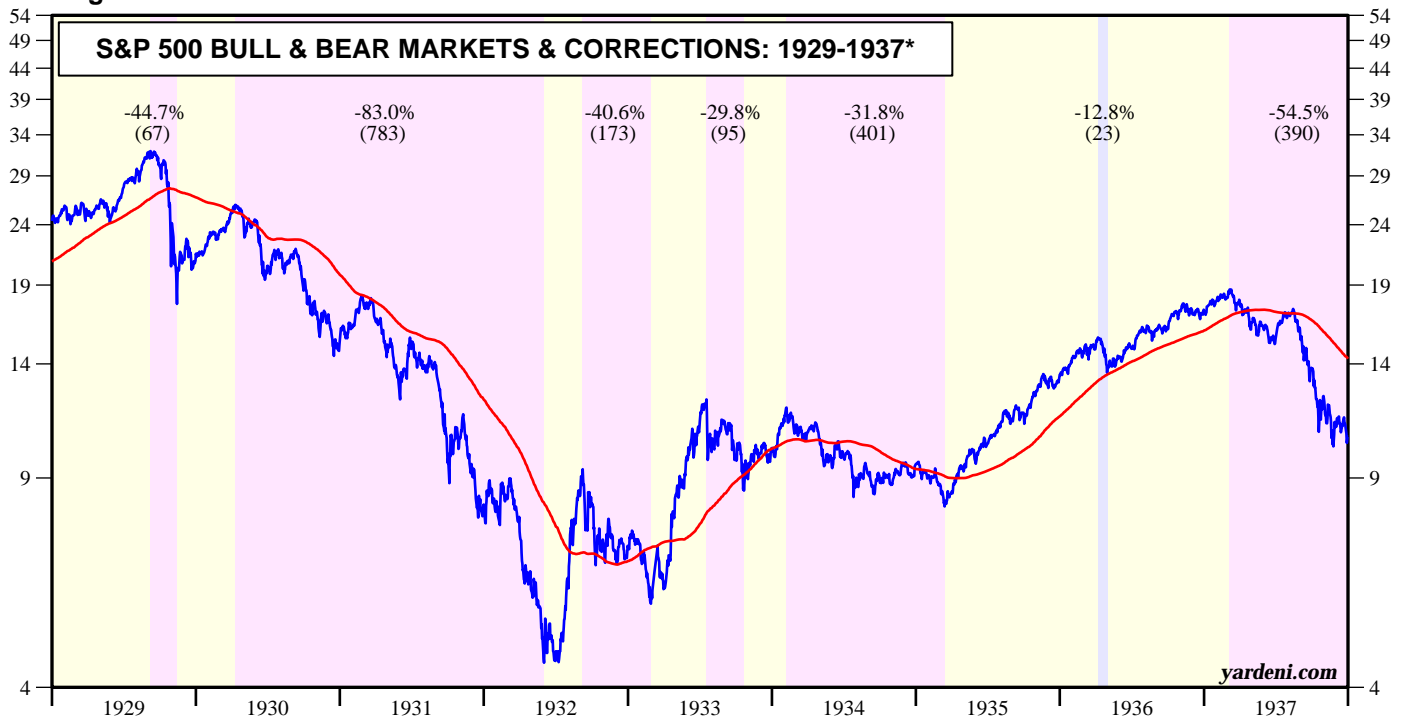
