# What best practices should the board follow in governing the organization?

- Board should consist of at least 3 unrelated individuals.
- > Be familiar with and follow Articles and Bylaws.
- > Have regular, well-planned meetings

### How do I keep my 501(c)(3) status?

- ➤ Maintaining 501(c)(3) Exemption
  - ✓ Monitor operations for IRS compliance
  - ✓ Notify the IRS if you make changes
  - ✓ Review Form 1023
  - ✓ Review Form 990

# We don't have to worry about taxes since we're tax exempt, right?

- > 501(c)(3) tax exemption relates to federal income tax
- Exception for Unrelated Business Income
- > Annual Filings

  - √ Form 990-T (if UBIT)
