**In order to mitigate the negative effects of disintermediation, participant transfers from the Wells Fargo Stable Value Fund C (CIT) are subject to an industry standard "Equity Wash" rule. This means participants are prohibited from transferring from the Wells Fargo Stable Value Fund C (CIT) directly to "Competing Funds" and may only make transfers from the Wells Fargo Stable Value Fund C (CIT) to Non-Competing Funds. Participants wishing to transfer amounts from the Wells Fargo Stable Value Fund C (CIT) to Competing Funds must first transfer to Non-Competing Funds, where the amount originally transferred must remain for 90 days before the participant can then transfer the amount to one or more Competing Funds. The self-directed Brokerage Account option is considered a Competing Fund since it offers money market funds and short-term bond funds. Therefore, transfers from the Wells Fargo Stable Value Fund C (CIT) to any investment within the self-directed Brokerage Account option and the Vanguard Prime Money Market Institutional are subject to the 90-day Equity Wash rule.

Tier 3 – Self-Directed Brokerage Option

If you are seeking options outside the target date and core menus, you can choose the self-directed brokerage option. The 401(a) self-directed brokerage option includes mutual funds, ETFs and individual securities.

With this option, you choose your own investments from the thousands available to you, and you can buy, sell, or transfer funds online or by phone. Please note: All purchase fees will be waived for
